# TITLE 1, CALIFORNIA CODE OF REGULATIONS SUBMISSION OF REGULATORY ACTIONS: AMENDMENT OF SECTIONS 6, 6.5, and 8

### NOTICE OF MODIFICATION TO TEXT OF PROPOSED ACTION

NOTICE IS HEREBY GIVEN that pursuant to the requirements of Government Code section 11346.8(c) and section 44 of title 1 of the California Code of Regulations, the Office of Administrative Law (OAL) hereby provides a notice of modifications to additional regulatory text.

On May 12, 2023, the Notice of Proposed Action (NOPA) was mailed in compliance with the requirements of Government Code section 11346.4. The NOPA stated that the changes proposed in the rulemaking action would reduce the number of hard-copy and electronic documents required for submission of certified regulation text to OAL. At that time, the proposed regulatory changes affected sections 6 and 6.5.

OAL inadvertently omitted changes to section 8, which also necessitated a change to reduce the number of copies required for submission of certified regulation text to OAL. Thus, OAL hereby adds amendments to section 8 to this rulemaking action as follows:

### §8. Final Text: Underline and Strikeout.

- (a) For the purposes of this section:
- (1) the term "regulation" includes authority and reference citations; and
- (2) the term "final text" meansrefers to the certified copy or copies of the

regulation or order of repeal transmitted to OAL for filing with the

Secretary of State <del>and the six copies required <u>byin</u> accordance with</del> Government Code section 11343 <u>and sections 6 and 6.5 of this title.</u>
